REMANUFACTURED COMPRESSOR LIMITED WARRANTY

Compressor Coverage

ARRCO, LLC provides its independently remanufactured Scroll Compressors with a Limited Warranty. For the period of the first one (1) year from the date of the original installation ARRCO will provide 1 free replacement compressor to the original purchaser, through a licensed service contractor/ARRCO Distributor, if the unit should fail under normal use during the coverage period, because of a defect in materials or workmanship during the remanufacturing process.

The purchaser must pay shipping charges and all other costs of warranty service. ARRCO, LLC will not pay for refrigerant or labor involved in diagnostic, removing, repairing, servicing or replacing any item. Labor and/or service costs may be covered by a separate warranty offered by the installer.

For the warranty to take effect the unit must have been installed by a state certified or licensed service contractor in accordance with the compressor installation/operation/maintenance instructions, using all of the new components, (Filter Drier, Capacitor and Contactor), which are available with each ARRCO compressor kit.

Each compressor must be properly registered within 30 days after the original date of installation for warranty to take effect.

To register: You or the installer must fill out the warranty registration form included with each compressor kit. The installer will sign the form and each of you will keep a copy. Mail a copy of the registration form to:

The installation of a replacement compressor and/or parts under the terms of this Limited Warranty does not extend the original warranty period.

WARRANTY LIMITATIONS

- 1. THIS LIMITED WARRANTY IS ISSUED IN LIEU OF ALL OTHER WARRANTIES, EITHER EXPRESSED OR IMPLIED.
- 2. This Limited Warranty is void if the covered compressor is removed from the original installation site.
- 3. This Limited Warranty does not cover damage or defect resulting from improper installation, operation of compressor at voltages other than the range specified on the compressor nameplate (including damages caused by brownouts), use of contaminated refrigerant or refrigerant not compatible with the unit, and any damage caused by fire, lightning or flood.
- 4. Arror reserves the right to send an Arror representative to the jobsite within a reasonable time to inspect any warranty compressor before it is removed from the installed system.
- 5. The Limited Warranty is void if there is debris or acid left in the system from a previous compressor failure.
- 6. All repeat product failures must be returned for special inspection. Request for inspection must be made to customerservice@arrcollc.com . If upon inspection no manufacturing defect is found the warranty claim will be denied by Arrco. A Special inspection charge of \$100.00 will also be applied.
